Riverview Investment and Financial Services

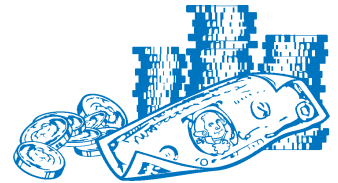
Effective February 8, 2012, Riverview Credit Union will no longer offer Riverview Investment and Financial Services. This means that Retirement Planning, Insurance, and Investments will no longer be available through RCU. For members that already have these products, your accounts will still remain the same. TREASURY CHANGES IN PRESIDENTIAL \$1 COIN PROGRAM

A decision was made by the Treasury Department, which will change the implementation of the Presidential \$1 Coin Program. Secretary Geithner has approved an immediate suspension of the minting of \$1 coins required under the provisions of the Presidential \$1 Coin Act of 2005. This means that the President Chester A. Arthur \$1 coin will not be released for circulation in February 2012 as planned. There is also no plans to produce further Presidential or Sacagawea \$1 coins for circulation. The U.S. Mint, however, will make a limited number of these coins available for numismatic purposes on its website.
